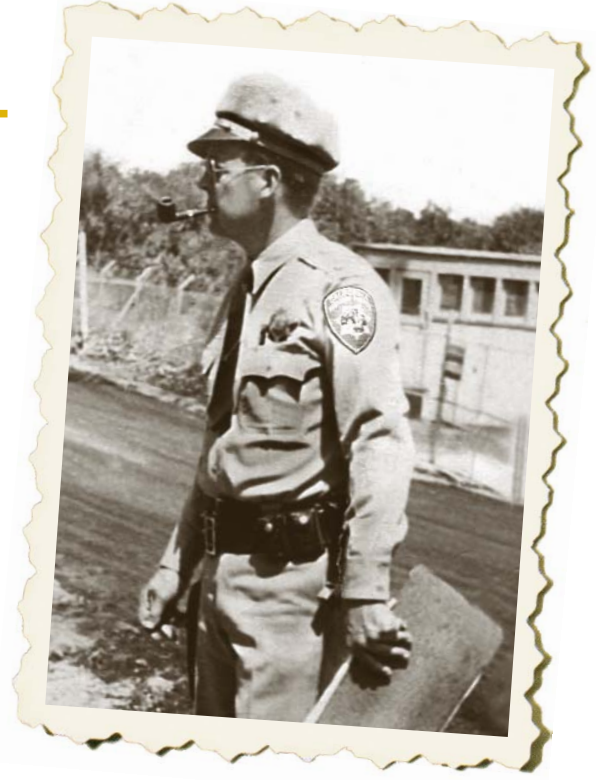

Gift Planning Makes Wayne Reynolds a Timeless Hero for Thousands

CHP Officer's Estate Supports CHP Families

Now-deceased California Highway Patrol Officer Wayne Reynolds was born during World War I. As an Enlisted Commercial Pilot member of the U.S. Army Air Forces Reserve, he served his country during World War II. Following his military service, he served the citizens of California for 22 years, as a sworn Officer of the CHP, in Orange and Los Angeles Counties. Officer Reynolds died in 1999, at the age of 84.

Consistent with her late father's estate plan wishes, in November, 2005, one of Officer Reynolds' surviving children, Carole Logsdon, graciously contacted the CHP 11-99 Foundation and dutifully provided a \$200,000 donation from her

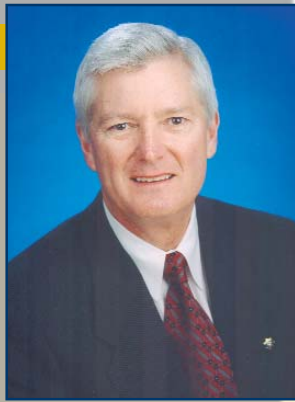
father's estate to support the 11-99 Foundation's programs!

CHP Officer Wayne Reynolds' long-planned major gift now is being used to support the CHP 11-99 Foundation's Benefits and Scholarship Programs, which provide emergency and death benefits and college scholarships to assist thousands of CHP family members. Chairman's Message

One of our favorite sayings at the CHP 11-99 Foundation is that “for the first ten years of the Foundation, it was run out of Bob Weinberg’s check book.” And it was! We had no full-time employees in the early days, and Bob was involved in every funding decision. Becky Centner, who was Bob’s assistant in his business, took on the added tasks of administering the Foundation—a part-time effort. Later, Becky transitioned to a full-time employee, and was then promoted to the position of Executive Director. She supplemented the staffing needs with some part-time help.

But then: Katy bar the doors! Every aspect of the Foundation has grown explosively. Let’s look at some of the programs that we have taken on over the years—as well as those in the planning stages:

- Two major annual golf tournaments: one in Southern California and one in Northern California.
- Several local events, such as: crab feeds, concerts, movie screenings, car shows, etc.
- A total revamp of the membership structure: including contracts with suppliers for the amenities.
- A formal scholarship program that involves over 1,000 applicants per year—all done with our proprietary software; over the Internet.
- A very high quality newsletter for keeping our membership informed.
- Greatly expanded CHP employee benefits for death or hardships.
- Training programs for CHP employees.
- Benefit coordination was brought in-house this year.
- A planned giving program is nearly ready to launch.
- Our membership has grown tenfold in the last decade.
- We now manage an investment portfolio of over \$20 million.
- The number of full-time staff has grown to six, supplemented at any given time by several contractors and consultants.

The enormous task of operating this organization requires exceptional people, with an exceptional degree of commitment. Thank goodness we have them! Of course, with more people and more tasks, comes the need for a stronger structure. So, I am pleased to announce the Foundation’s new management and staff structure:

In addition, we have enhanced our board leadership by promoting John Schroeder, a longtime director, to the position of Vice Chairman, and Scott Siegel has transitioned to Secretary. Scott and his family have been involved with the Foundation since its inception, and will help to continue the tradition of Bob Weinberg.

The 11-99 Foundation prides itself on running an efficient, low-cost operation, and each of these dedicated people wears several hats. We are truly fortunate to have developed such a capable and committed staff. I am extremely proud of each one of them, and I hope that you will support them and their mission at every opportunity. I believe that our new organization has positioned the Foundation for the next phase of growth, and that it can accommodate that growth in an orderly manner—one that you can be proud of too.

Commissioner's Letter

My words here usually illustrate the bond of mutual respect between two extraordinary organizations, the 11-99 Foundation and the California Highway Patrol. Today I need to tell you instead about an extraordinary young man, the son of retired California Highway Patrol Officer Joe Landaker, Arrowhead Area.

Foundation members may recall Jared Landaker because you awarded him a college scholarship a few years ago.

The future as he saw it, and his gratitude to the Foundation, were briefly described in an article carried by our CHP magazine, ZENITH 12000.

Jared, a Marine first lieutenant and helicopter pilot, will never have the opportunity to experience that future. He died in February when his aircraft was shot down over Anbar Province in Iraq. Jared came home by plane a few weeks ago, his body accompanied by a Marine escort and the Landaker family. The trip was emotionally draining, as recounted by an anonymous observer who happened to be on the plane and posted an internet message describing the trip. This person was a pilot and former military man who himself had once escorted a fallen military hero on his last sad journey home, so he had a sense of how the Landakers felt.

So did the pilot, for he saluted with a double bank and roll, first left, then right, as the plane passed over the Big Bear area where the Landakers live. The observer's commentary concluded: "First Lieutenant Landaker, a man I came to know in the skies over America, from me to you, aviator to aviator, I am unbelievably humbled. It was my high honor to share your last flight. God bless you, Marine."

I think there is a powerful similarity between those in military service and those in service with the California Highway Patrol. Valor is a defining measure of both. That Lieutenant Landaker was a California Highway Patrol officer's son seems entirely fitting. The Landakers can be proud of Jared. And so can we, because in a very real sense we are part of their family.
